

Background

- This is a reoccurring contract for transmission replacements
- This contract will supersede current contract B42010 New Allison Bus Transmissions
- New contract contains FTA clauses which allow grant reimbursement of up to 80%
- There were three (3) respondents that submitted bids over twoline items
- New contract will include procurement, repair, and overhaul of any MARTA transit bus transmission
- Extended Warranty is included with all Transmissions

Transmission Procurements



- Transmission procurements will support bus midlife overhaul program
- Contract term is for Four (4) Years –
 No options
- Contract award for Transmission Procurement -\$6,971,132.00
- Eligible for FTA grant reimbursement of up to 80%
- Two (2) Respondents submitted bids
 - One (1) valid and one (1) invalid due to incomplete bid

Transmission Repairs & Overhauls



- Transmission repairs and overhauls will support buses <u>Outside</u> of Bus Midlife Overhaul Program
- Contract term is for Four (4) Years –
 No options
- Contract award for repairs and overhauls \$315,000
- Not eligible for grant reimbursement
- Two (2) Respondents submitted bids
 - Both respondents completed bids. One deemed competent due to dealer validity

- W.W. Williams Co., LLC Transmission Procurement \$6,971,132.00



Diesel Exhaust Fluid (DEF) is a liquid used to reduce the amount of air pollution created by a diesel engine. Specifically, DEF is a solution made with 32.5% urea and 67.5% deionized water





- DEF falls under the Clean Air Act that was put in place in the 1970s, the Environmental Protection Agency (EPA) has been making strides toward lowering emissions
- 40 CFR Part 86 Control of Emissions from New and In-Use Highway Vehicles and Engines
- In 2010 the EPA tightened restrictions requiring the use of DEF with all medium and heavy-duty diesel engines
- 166 are diesel buses and 18 non-revenue vehicles require DEF





Five potential bidders.

- \$304,800 Incomplete bid form
- \$375,500 Incomplete bid form
- **\$540,600** 5% DBE goal met through transportation efforts
- \$600,000
- \$841,200







MEAN DISTANCE BETWEEN FAILURES




