## Purpose

## **Consultant services provides critical support for the development and implementation of:**

- Corridor planning studies

- Environmental documentation
- Conceptual design/preliminary engineering
- Major transit facility studies
- Special projects/initiatives



## Need

- January 2023 expiration of existing contract
- Ensures continuity of studies and initiatives
- Ensures timely advancement of More MARTA Atlanta & Clayton projects, additional expansion, and other strategic priorities
- Allows flexibility with current staffing and future needs



## Background

- Past Contract Support
  - Duration: 5 years (3 years + 2 one-year options)
  - Budget: \$23M (2013) and \$66M (2018, increased to \$69.3M 2022)
- Proposed Contract Request
  - Duration: 5 years (3 years + 2 one-year options)
  - Budget: \$76M



## **RFP** Specifications

## Scope of work designed to:

- Encourage competition and enable timely continuation of studies
- Obtain technical capacity required for major expansion efforts
- Ensure specialized expertise
- Supplement Cyclical staff needs
- Issuance of Work Orders
  - Formal proposal and selection process for large work efforts to ensure appropriate project team members
  - Direct assignment of work orders for staff support and technical services of typical work



## **MARTA Considerations**

- On-call, as-needed work orders
- No commitment of funds
- No guarantee of work
- Contract vehicle to access resources
- Adaptable to potential expansion initiatives



### Location Map 1 Proposed Easement Agreement – Sycamore Street near Avondale Station






#### **Location Map 2 Proposed Easement Agreements – Paden Circle near East Lake Station**






#### Location Map 3 Proposed Easement Agreement – Park Place near East Lake Station






### Location Map 3 Proposed Easement Agreement – Sam's Street near Avondale Station

### STATUS

The current Structural Inspection Engineering Services 5 Year contract with Volkert, Inc. expires August 20, 2022.

The purpose of the new Structural Inspection Engineering Services Contract is to provide continued on-call structural inspection engineering support.

Structural Inspection Engineering Services are necessary on an on-call basis to provide detailed inspections of MARTA's structures (bridges, tunnels, parking decks, retaining walls, culverts etc.) as required by State and Federal requirements.



## SCOPE

The specific expertise during the proposed term of this contract may include, but are not limited to the following:

- Comprehensive inspection program
- Quality Control / Quality Assurance program oversight
- Performing destructive or non-destructive testing
- Structural condition assessments and rating recommendations
- Comprehensive data collection and management system with reports
- Performing other structural engineering consulting services as requested





### PROPOSED

- Intent to solicit procurement of one (1) Consultant in FY22.
- The term of the contract will be three (3) base years with two (2) one-year options.
- Expenditures are estimated at \$600,000 per year for a total five (5) year value of \$3,000,000.
- The services will be funded by approved projects within the relative fiscal year Capital Improvement Program.
- The Office of Diversity and Inclusion will review the proposal document during the pre-planning phase of the solicitation process to identify opportunities for disadvantaged, small, and minority business participation. [Current contract has 30%]

## Parking Lot Paving Program

- Fast-Tracked program addressing twelve (12) rail station parking lots
- Utilization of five (5) A&Es and four (4) CMARs as part of the Station Rehabilitation Program
- Program started on Friday, January 21<sup>st</sup> with assemblage of A&Es
- Scope of Work is to design and replace asphalt paving, concrete curb and gutter, make all ADA parking compliant with current regulations, clean and fix all drainage structures and piping.




### PURPOSE

- Existing Station parking lots are beyond their useful life
- Facilities Dept. has been maintaining as best as possible with what existing materials remain
- Replacement of parking lots have had multiple requests from patrons, Governmental Partners, and private groups




### COST

- The A&E & Geotechnical services are approximately \$1M (A&E Approx. \$60k/Site, Geotech Approx. \$20k/Site)
- The approximate construction cost is \$120M (\$10M per station)

### SCHEDULE

- A&Es released on January 21<sup>st</sup>. Design work expected to continue to end of March
- CMAR Pre-Const. start mid February
- CMARs anticipated to start construction in mid April
- Anticipated completion of all work by end of August 22






## **Roof Replacement – South Yard**

- Fast-Tracked project to replace failed roof at South Yard Rail Maintenance Facility
- Utilization of CMAR to complete the work, MARTA Infrastructure designed
- Estimated \$2.25M replacement cost
- Work expected to start April May
- Facility supports new Rail Car procurement as receiving/inspection location for new car arrival

## **TVS Feeder Cable Replacement**

### PURPOSE

Replacement of 3100 linear feet of Electric Feeder Cables

### SCHEDULE

 Material procurement and track availability allows for construction from February to March 2022.

### COST

The total construction cost of ~\$250k







## **SMART Restrooms**

- Scope of project is to convert, renovate and provide a vandal resistant unisex restrooms for all public restrooms within rail stations. First Wave stations starting construction:
  - Indian Creek
  - East Point
  - Doraville
  - HE Holmes
  - Dome/State Farm/Mercedes Benz
- Proposed to fast-track procurement of remaining sixty-seven (67) restroom fixtures from the vendor. Approximate cost is \$3.2M for the material procurement.
- Procuring materials now will:
  - eliminate overhead costs from a GC procuring the materials
  - Start production of long-lead time materials (13-18 weeks) to get onsite and get program started sooner.
